

## General Data Provision Information

### Dear Participant in the Training,

We hereby inform you that our training programs are conducted as an adult education provider operating under Act LXXVII of 2013 on Adult Education (hereinafter referred to as Act LXXVII of 2013).

According to Section 15 of Act LXXVII of 2013, the adult education provider is required to submit data to the adult education administrative authority through the adult education data reporting system. This includes the personal identification data, email address, the highest level of education attained by the participant, the training fee, and the entity covering the cost.

For the purposes of identifying, verifying, and correcting personal data managed in the adult education data reporting system, as well as for the operation of the follow-up system, through the comparison of the natural personal identification data of the participant

a) According to Section 9 (1) of Act LXVI of 1992 on the Registration of Citizens' Personal Data and Addresses (hereinafter referred to as: Act LXVI of 1992), the authority managing the registry concerning the person participating in the training

aa) as defined in Section 11 (1) points a), d), and e) of the Act LXVI of 1992 ensures the verification of the data specified therein, and transfers the data specified in points b), c), and h) of the same paragraph using the central governmental service bus,

ab) The authority responsible for operating the educational registry that issues the educational identification number shall transfer the data of the participant in the training as defined in Section 2 (I) of Act LXXXIX of 2018 on the Educational Registry, or

b) Through the comparison of the participant's personal identification data, the service provider designated by law for the operation of the linkage register shall provide data via the linkage register concerning the data specified in Section 3 (1) points a) and b) of the Onytv

free of charge and electronically to the adult education data reporting system.

The adult education administrative authority shall maintain an electronic register of the data transmitted within the framework of data provision, the data accessed, and the certificates issued by the adult education provider – for the purpose of the inspection specified in Section 20 (1) and the operation of the follow-up system – and shall manage the data in the register until the last day of the fiftieth year following their creation. The adult education administrative authority shall manage the data of the central register containing the certificates until the last day of the fiftieth year following their creation, after which the data shall be transferred to the competent archives and deleted from the register.

The data may be used for statistical purposes and may be transferred for such purposes in a form that does not allow personal identification. Additionally, the data may be provided free of charge to the Hungarian Central Statistical Office for statistical purposes in a form that allows individual identification and used accordingly.

This translation was prepared based on the original Hungarian document. In all respects, the original Hungarian translation shall prevail.
